Note: All riders in all Western ridden classes at APHC approved and/or APHC UK shows or events are required to execute this release or they will not be allowed to compete at any APHC UK show.

This participant's Agreement and Release of All Liability and Claims ("Release") is executed by the undersigned Person ("Participant") on the date and at the place set forth below.

THE PARTICIPANT UNDERSTANDS THAT THE APHC AND THE APHC UK STRONGLY ENCOURAGES THE USE OF BHS/EU/ASTM APPROVED PROTECTIVE HEADGEAR IN ALL APHC AND APHC UK WESTERN RIDDEN CLASSES INCLUDING BAREBACK EQUITATION, FREESTYLE TO MUSIC, GAMES CLASSES AND THAT WEARING PROTECTIVE HEAD GEAR AT ALL TIMES WHEN MOUNTED CAN PREVENT SERIOUS INJURY OR DEATH.

In consideration of being permitted to participate in Western ridden classes at Appaloosa Horse Club (APHC) and APHC UK Ltd approved and / or sponsored horse shows or events, Participant, for himself or herself, and for his or her legal representatives, heirs, distributees and assigns (collectively "releasors"), hereby releases, waives and discharges the APHC and the APHC UK Ltd, its affiliated organisations, including but not limited to Directors, show management, sponsors, promoters and advertisers and the owners and lessees of any premises upon which any APHC or APHC UK Ltd approved show or event is held; and each of them, their Directors, officers, employees, agents, contractors and members (collectively "Releasees") of and from any and all liability, action, claim, demand, expense, loss or damage of whatever kind or nature to Participants and Releasors arising from personal injuries, death or property damage to the Participant or others arising directly or indirectly from or attributable in any way to the Participant's participation in any Western ridden class or other classes entered at any APHC or APHC UK Ltd approved and/or sponsored horse show or event whether caused by the negligence, action or omission of Releasees or any other cause; and hold harmless, indemnify and agree to defend APHC and APHC UK and Releasees from any and all claims arising from Participant's participation in any such Western ridden class or classes.

THE PARTICIPANT VOLUNTARILY DESIRES TO PARTICIPATE IN WESTERN RIDDEN CLASSES AND OTHER CLASSES AS ENTERED WITHOUT APPROPRIATE PROTECTIVE HEADGEAR WITH THE FULL KNOWLEDGE OF THE DANGER INVOLVED AND HEREBY AGREES TO ACCEPT ANY AND ALL RISKS OF INJURY AND DEATH.

The Participant, for himself or herself, and Releasors, agrees to indemnify Releasees, and each of them, from any loss, liability, damage or cost that may incur due to Participant participating.

I HAVE CAREFULLY READ THIS RELEASE AND FULLY UNDERSTAND ITS CONTENTS. I INTEND THIS RELEASE TO BE BINDING ON ME AND RELEASORS. I AM RELEASING LEGAL RIGHTS THAT I MAY HAVE AND I SIGN THIS RELEASE OF MY OWN FREE WILL.
